

ARCHIVAL POLICY

Introduction:

In terms of Regulation 30(8) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "SEBI Listing Regulations"), every listed company shall disclose on its website all such events or information which has been disclosed to stock exchanges (the "Stock Exchanges") where the securities of the Company are listed under Regulation 30 of the SEBI Listing Regulations. Further, such disclosures shall be hosted on the website of the Company for a minimum period of 5 years and thereafter as per the archival policy of the Company, as disclosed on its website.

Accordingly, the Board of Directors (the "Board") of Jiwanram Sheoduttrai Industries Limited (the "Company") have adopted the following policy on its Board Meeting dated 12.06.2023.

Purpose & Scope:

The purpose of this Policy is to determine the period of record keeping and preservation of the physical as well as electronic records of the Company. Pursuant to the Regulation 30 of the SEBI Listing Regulations, the Company shall disclose on its website all such events or information which has been disclosed to Stock exchanges, and such disclosures shall be hosted and retained on the website of the Company for a minimum period of 5 (five) years and thereafter, as per this Policy. This Policy defines the time period for which material events are likely to affect the working of the Company and be disclosed on the Company's website after the lapse of the aforementioned minimum period of five years.

The policy will be applicable to the Company.

Definitions:

"Policy" means this Archival Policy.

"Material Events" means events as specified in Schedule III to the Listing Regulations and upon the occurrence of which a listed entity shall make disclosures to stockexchange(s) and host such disclosures on the listed entity's website.

Policy:

Disclosed information after more than five years, shall be kept in the archives of the Company for a period of 3 years. Anyone intending to review those disclosed informationmay write to Compliance Officer of the Company.

In case, the aforesaid disclosures are required by any applicable law or regulation to be hosted for a period longer than that mentioned above, such disclosures shall be hosted on the website of the Company for such longer period.

Amendment:

Any change in the Policy shall be approved by the Board of Directors of the Company. The Board of Directors shall have the right to withdraw and / or amend any part of this Policy or the entire Policy, at any time, as it deems fit, or from time to time, and the decision of the Board in this respect shall be final and binding.

In case any provisions of the Policy are contrary to or inconsistent with the provisions of the Companies Act, 2013, rules framed thereunder and Listing Regulations ("Statutory Provisions"), the provisions of Statutory Provisions shall prevail.

Officer responsible:

The Company Secretary and any other person authorized by the Board of the Companyshall be responsible for ensuring overall compliance of this Policy.
